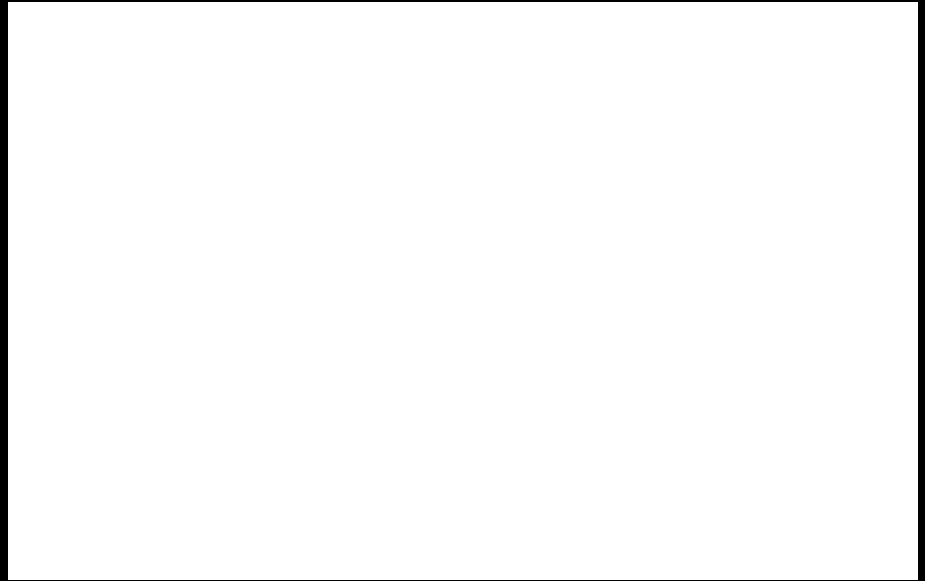

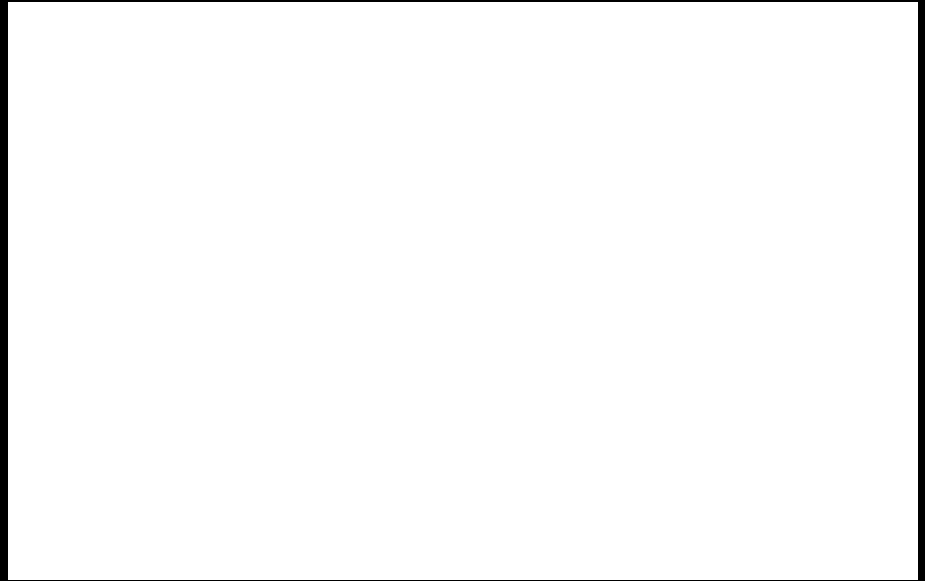

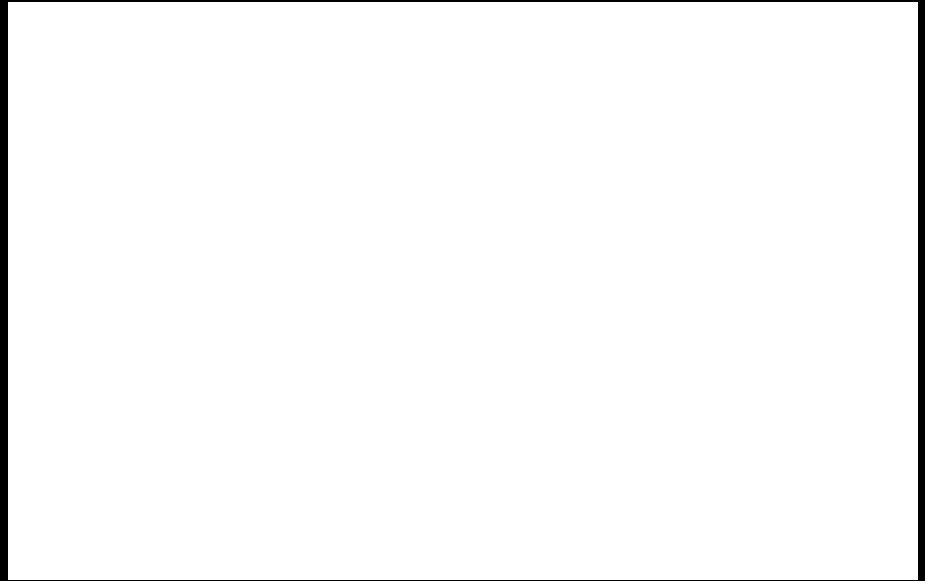

TURNAROUND - NORMAL (figure max: 1 week design, 1 week production)

- Design Slide. 1 - 7 workdays
(about 1 - 7 workdays from receipt of complete order form, photos, copy, co. logo)
Allow time for your client approval. GDS can post layout(s)
to our website for immediate client viewing & approval at:
www.garsondesign.com/proofs/PCI
- Rcv. changes (only way to send changes is via fax to 707 428-3652)
- GDS make changes & fax back for final approval
We can fax directly to you or to your client on your behalf.

- Go-ahead received from theatre by 1pm: Day 1
GDS FX out same day for slide production.

- Go-ahead received from theatre after 4pm: Day 1
We would have to modem out for slide production...
OK if not too big of a file (up to 5mb).
Otherwise goes out next day.

- Vendor receive, FX out to GDS: Day 2 or 3

- GDS receive from Vendor, deliver FX out to Theatre/Cinema: Day 3 or 4

The vast majority of slides are done in the above Normal Turnaround, but in those cases where the slide needs to be on-screen for an opening, or client waited to the last minute, please note the following option:

RUSH TURNAROUND EXTREME RUSH CUTS TIME IN 1/2 (+50% SURCHARGE)

- Design Slide. 1 - 7 workdays
(about 1 - 7 workdays from receipt of complete order form, photos, copy, co. logo)
Allow time for your client approval. We can post layout(s)
to our website for immediate client viewing & approval!

 - Rcv. changes (only way is via fax to 707 428-1743)
 - GDS make changes & fax back for final approval
We can fax directly to you or to your client on your behalf.

 - Receive go-ahead from theatre by 10am: Day 1
• GDS print out in color (letter or larger at tabloid size)
• Take slide photo of color printout
• Take to (Vendors who have one day slide turnaround):
• GDS receive from Vendor, deliver or FX out to Theatre/Cinema that evening.

 - Receive go-ahead from theatre after 10am: Day 2
- Remember the above are ideal turnarounds, barring occasional unforeseen mishaps, like lost FX truck, vendor delay (equipment breakdown, etc.)
